### REMINDERS & NOTES

- Vendors are required to carry liability insurance. The Fair has insurance options available if needed.
- If you are selling taxable items we require your NYS Tax # & certificate of authority.
- Food vendors are required to obtain a NYS department of Health permit to operate a temporary food establishment. Permits can be acquired through the Geneva District office.
- Dumping of Grease is only permitted in designated areas. This location will be shown on your map in provided packet as we get closer to the Fair.
- No trash is to be in garbage bags on the ground. It must be placed in garbage containers provided by our sponsor K&D Disposal.
- Anyone interested in selling food in the grandstands must request a permit ahead of time through the vendor office. No Candy or water is allowed to be sold.
- Set up time for booths and displays are the weekend before the fair (August 6th & 7th). All booths must be in place by 9:45 am Monday morning.
- Fair opens daily at 10am and buildings are closed and locked at 10pm.
- The Fair provides security on the grounds 24 hours a day.
- We require your booth is in place until Sunday Morning at 8am. No vehicles will be allowed on exhibit grounds before that time.
- Absolutely no dogs or pets are allowed on property during fair week. The exception is services dogs. Services dogs are allowed if proper paperwork is presented to a member of the Board of Directors of the fair.
- Shoes and shirts are required at all times.

### VENDOR CONTRACT

Union Agricultural Society at Palmyra a/k/a. the Wayne County Fair does not provide tables or chairs for your use. Vendor set up times will be available **Saturday and Sunday August 6th & 7th from 9am to 4pm**. This privilege is accepted upon condition that the business or use above stated is to be conducted in accordance with the Rules and Regulations of the Union Agricultural Society at Palmyra, which are used in transacting the business to which this privilege pertains. We reserve the right to prohibit or limit the use of bullhorns, music, pickets, plaques, demonstrations, etc., inside our outside of your area.

**You may not dismantle or remove your display until Sunday August 16th. Penalty is forfeiture of space in the following year.** No vehicles are allowed on the Fairgrounds until Sunday August 16, 2022. The location for said privilege to be assigned by the society and the business of running such privileges to be conducted to the satisfaction of the society. Retention of this contract on the part of the purchaser will be taken as evidence of acceptance. The Union Agricultural Society of Palmyra assumes no responsibility for the loss or damage of Lessee's property. Contract subject to Lessee's securing license from Department of Agricultural of this state. (if required). Certificate of Insurance and Certificate of Authority are required. No pets are allowed on the grounds the week of the fair; service animals are allowed on the grounds during the week of the fair with proper documentation. Society reserves the right to reject or terminate any contract at its discretion.

Certificate of insurance must include a 15 day written notice of cancellation to, Union Agricultural Society at Palmyra, NY, a/k/a The Wayne County Fair. All certificates of insurance shall be filed with The Wayne County Fair and must be presented to the Fair's Vendor Superintendent, and the Fair's Insurance Person, on or before 14 days prior to your event. The insurance policy must not be less than \$1,000,000.00 and with insurers authorized to do business in the State of New York.
